

CA-NMRNMANXX	WHERE NXX = LENGTH IN INCHES	CA-NMRNMAN16 (16 INCHES)
CA-NMRNMAMXX	WHERE MXX = LENGTH IN METERS	CA-NMRNMAM07 (7 METERS)
CA-NMRNMAXMX	WHERE XMX = LENGTH IN DECIMAL METERS	CA-NMRNMA3M5 (3.5 METERS)
