

CA-SSMNFAXXX	WHERE XXX = LENGTH IN FEET	CA-SSMNFA010 (10 FEET)
CA-SSMNFANXX	WHERE NXX = LENGTH IN INCHES	CA-SSMNFAN16 (16 INCHES)
CA-SSMNFAMXX	WHERE MXX = LENGTH IN METERS	CA-SSMNFAM07 (7 METERS)
CA-SSMNFAXMX	WHERE XMX = LENGTH IN DECIMAL METERS	CA-SSMNFA3M5 (3.5 METERS)
